## **Parking Rules**

General conditions for the use of unattended vehicle parking. The customer of the car park, when purchasing the ticket, expressly accepts these general conditions of use of the car park. In the event the user, upon viewing, does not intend to accept them, he is required to leave the parking area immediately within 10 minutes without being charged any fees; after this period of time without the user leaving the parking lot, these conditions will be considered tacitly accepted. 1) With the withdrawal of the admission ticket and the subsequent payment, the user is exclusively granted the right to occupy, within the limits of the spaces available, a vehicle space, since the manager with the sale of the title merely leases the space corresponding to the place car, excluding any activity of safekeeping, storage and surveillance of the same. The manager is therefore exempt from any liability and / or compensation for any theft or damage, even partial, caused by third parties to people, things, vehicles, both parked and in transit, and the objects contained therein. 2) Access to the parking area is allowed for two or more wheeled vehicles, including campers, caravans, motorcycles and mopeds, as well as light commercial vehicles, which have a regular license plate. Access to bicycles, medium and heavy commercial vehicles, and animal traction vehicles is not allowed. 3) The ticket is valid for one day and must be used on the same day it is purchased and the park is accessed. 4) The possible presence, in the parking area, of service staff employed by the manager does not imply the assumption by the latter of custody, storage or surveillance obligations of the parked vehicle, for any reason. 5) The parking area, reserved exclusively for park users, is accessible on all park opening days, including holidays, starting from one hour before the opening of the park up to half an hour after the closing of the latter. 6) For the use of the parking service, the user is required to pay, before leaving, the amount due for parking according to the rates in force and the methods established by the manager and made known at the entrance to the parking. In case of loss of the ticket, the customer will have to pay an amount equal to the full rate for the whole day. 7) The time available between the payment of the ticket and the exit from the car park with the car, to avoid further charging of fees as an extension of the parking, is 30 minutes. 8) It is forbidden to make commercial or sales requests of any kind inside the car park. Those who contravene this prohibition may be invited to leave the parking lot by the security staff, unless reported to the Public Security Authority. 9) The consumption of food and drinks within the parking area is prohibited. Those who violate this prohibition may be asked to comply with this rule by security personnel. 10) Users are not allowed to stay in the parking area beyond the time strictly necessary for entry, parking and exit operations, after which the security staff will be authorized to invite users who unjustifiably stayed there, to leave; the exercise of this power by the manager does not imply any assumption of responsibility for theft or damage to things or people inside the parking lot. 11) The user of the parking lot must remove the vehicle from the parking area no later than the closing time of the parking lot, which is made known by the operator when purchasing the ticket. Vehicles that are not removed within the closing time of the car park can be removed by the manager at the expense and risk of the person entitled to return the vehicle, and sent to the public depository of the Municipality of Valmontone. The owner of the vehicle will be charged the price for the prolonged occupation of the parking space, as well as any other costs or costs incurred by the operator for the removal and custody of the vehicle at the destination depository. 12) As the purchaser of a ticket, the user must park the vehicle so as to occupy only one of the parking spaces inside the parking lot, with the engine off, and the vehicle braked and closed. Parking is prohibited outside the spaces specifically delimiting the parking space, and in the parking spaces reserved for disabled people where you are not entitled to the treatment reserved for them in the movement, use and parking of vehicles. It is forbidden to stop along the sliding lanes and near the entrances and exits. Irregularly parked vehicles can be removed by the operator, at the user's expense, and without any liability for the operator for any damage that may occur during transport to the Valmontone municipal depository. The surveillance

staff is authorized to take photographs, having probative value, in order to demonstrate the irregularity of the parking and the legitimacy of the intervention. If not sent to the public warehouse, the vehicle will be returned to the rightful owner, or to his assignees, only after reimbursement of the removal and hospitalization costs to the manager; if the manager had possibly paid the public depository sums in whole or in part for the deposit of the vehicle removed from the parking lot, the person entitled to return the vehicle undertakes to reimburse the manager for any such burden and expense, and in any case undertakes to keep it free from any related prejudicial consequence. 13) Inside the car park, the user must comply with the rules of the highway code, the vertical and horizontal signs affixed and set up by the operator, as well as any other indication provided by signs, or verbally by the operators; in any case, the user is required to proceed at speeds not exceeding 30 km / h. 14) The user is responsible for damage caused by him, or his companions, to the systems, equipment and instruments that are in the parking lot, to the manager's surveillance staff and / or to third parties or to things belonging to them. In the event of damage due to knocks, collisions, accidents, investments caused by users inside the parking lot, the operator is not liable for such damages, except in the case of willful misconduct or gross negligence, to be assessed in relation to the performance contractually assumed by this, and consisting in the mere and exclusive rental of spaces consisting of parking spaces. 15) It is forbidden to leave animals, flammable or explosive materials, valuables in parked vehicles, to carry out any type of fuel or other liquid or flammable substance transfer, to perform or have the vehicle cleaned, light fires and cook food. 16) It is forbidden to park vehicles with leaks from tanks or affected by other defects likely to damage the parking area. 17) In the event of a malfunction of the parked vehicle that prevents its removal, the removal of the vehicle by means of removal managed by authorized workshops may be allowed, it being understood that the vehicle must still be removed from the parking lot, possibly at the initiative of the manager, neither the repair of the vehicle on the parking area nor its permanence beyond the closing time is allowed. 18) The manager reserves the right to suspend or interrupt the parking service for reasons of public interest, public utility, or force majeure, excluding any liability in this regard. In these cases reimbursement of the ticket price is excluded. 19) The manager is not liable for any acts of vandalism committed by third parties, as well as for damages deriving from natural disasters, causes of force majeure or acts of the Authority. 20) Any responsibility for the loss or theft of the objects left inside the parked vehicle will be borne only by the users. 21) Any complaints must be reported, under penalty of forfeiture, to the parking surveillance staff before exiting the parking lot, which must be followed promptly and regularly by the competent police authorities.
