General conditions for the use of the MagicPass

WHAT IS THE MAGIC PASS?

It is an easy-to-use bracelet that allows you to shorten the waiting times of the main attractions.

WHAT IS THE GOLD MAGIC PASS?

It is an easy-to-use bracelet that allows you to shorten the waiting times of the main attractions, and grants you unlimited access to all the attractions included in the program.

DOES THE MAGIC PASS ALLOW YOU TO AVOID THE FILES?

No, it shortens waiting times by allowing you to access attractions from a privileged route.

HOW MANY PEOPLE CAN USE THE MAGIC PASS?

Magicland offers its visitors a limited number of MAGIC PASSes every day. The number varies according to the visitors present inside the Park.

WHERE IS IT POSSIBLE TO PURCHASE THE MAGIC PASS?

The MAGIC PASS can be purchased at the Main Street Sud shop located in the Magic-Street of the Park. Following the purchase, the Guest accepts the Service Regulations, which are shown below.

MAGIC PASS REGULATION

Thank you for purchasing the Magic Pass. Please read these simple instructions carefully in order to use your MAGIC PASS card correctly.

1. BASIC INSTRUCTIONS.

The card is not personal, it allows access to each attraction included in the specific list. The attractions in which the MAGIC PASS fast access has been activated are those listed in the list inserted in point 2; At each access to the attractions, the staff in charge will cancel the attraction box on the card. For general organizational reasons, inside the MagicLand facility, the places reserved for each attraction for MAGIC PASS card holders are identified according to the following scheme:

2. HOW TO ACCESS THE ATTRACTIONS.

Based on the opening hours of the Park, the opening of the individual attractions, but above all on the basis of your interest, you can go to the chosen attraction at any minute. It is normal that if all visitors who have purchased the MAGIC PASS card simultaneously choose the same attraction, they may be asked to wait a few minutes. Each attraction accessible with a MAGIC PASS card has a reserved entrance, indicated by the MAGIC PASS ENTRANCE sign. The reserved entrance can be placed at the entrance of the attraction or at the exit of the attraction. Check the signs near each attraction and, if you cannot find the reserved entrance, ask the Rainbow Magicland staff.

3. FURTHER USEFUL INFO

A. FULL

It may happen that some attractions have a very long line both for the MAGIC PASS entry and for the normal one. We recommend that you give way to other attractions. We guarantee, however, in case of normal operation of the attraction, that before the park closes you will be given the opportunity to enjoy the attractions. We also ask you not to wait for this time with more than two attractions still to be used. If the attractions to be used at the closing time of the Park are more than two, access to two attractions will be limited in relation to your choices and among those that you have not yet used.

B. UNEXPECTED EVENTS

If for any reason (technical, meteorological, etc.) an attraction or all of them should close, you can get information about the reopening times and more at our Customer Service office at +3 06 95318518.

C. GENERAL RULES FOR ACCESS TO ATTRACTIONS

Before accessing an attraction, visitors are always required to inquire about the safety rules and age/height limits, which are listed below: In the attractions where children are expected to be accompanied, both users must have a MAGIC PASS card to access the attractions. In the event the MAGIC PASS cards have been sold to a group, access will still be allowed in the times and in the manner indicated in the diagram shown in point 1. Magicland reserves the right to unilaterally modify the availability of access to attractions due to causes force majeure, operational and / or safety needs. Although not provided for in these regulations, the reference is as provided for in the general Park Regulations.

D. RESERVED SEATS AT GRAN TEATRO

MagicPass holders are entitled to access (subject to availability) to seats reserved for the Gran Teatro.

E. RESTAURANT ACCESS

Privileged Fast Food / Self Service access

F. VALIDITY

MAGIC PASS are subject to limited availability, are valid for one day and are not refundable, even in the event of unforeseen unavailability of one or more attractions included in the package.

Nui-Lua

Access limitations: minimum height 90 cm accompanied – 120 cm non-accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Shock

Access limitations: minimum height 130 cm – maximum 200cm – for further requirements, consult the specific sign at the entrance to the attraction.

Cagliostro

Access limitations: minimum height 120 cm – maximum 195 cm – for further requirements, consult the specific sign at the entrance to the attraction.

Mystika

Access limitations: minimum height 140 cm accompanied – 150 cm non-accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Rapids

Access limitations: minimum height 121 cm – maximum height 195 cm– for further requirements, consult the specific sign at the entrance to the attraction.

Yucatan

Access limitations: minimum height 121 cm – maximum height 195 cm– for further requirements, consult the specific sign at the entrance to the attraction.

Huntik 5D

Access limitations: minimum height 100 cm – children under 130 cm in height must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

The Flying Dutchman

Access limitations: minimum height 110 cm – children under 130 cm in height and age between 4 and 8 years must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Battleship

Access limitations: 95 cm in height and 6 years of age minimum– children under 121cm in height and 3 years of age must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Maison Houdini

Access limitations: 120 cm in height and 8 years of age minimum– children of age less than 8 years must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Dune

Access limitations: minimum height 95 cm – children under 4 years of age and 122 cm in height must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Gattobaleno Time Machine

Access limitations: minimum height 95 cm – 3 years-old children less than 95 cm in height must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Flying Island

Access limitations: minimum height 120 cm – children under the height required must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Esplorabruco

Access limitations: minimum height 95 cm - children under 120 cm in height must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Safari

Access limitations: minimum height 90 cm – children under 105 cm in height must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Magic Pillar

Access limitations: minimum height 105 cm – children under 120 cm in height must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Magic Pond

Access limitations: 105 cm in height and 4 years of age minimum – children of age less than 10 years must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Ping the Spider

Access limitations: minimum height 90 cm – children under 120 cm in height must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Jungle Express

Access limitations: minimum height 90 cm – children under 105 cm in height must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Giranido

Access limitations: minimum height 90 cm – children under 105 cm in height must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Hot-air Balloons

Access limitations: minimum height 90 cm – children under 120 cm in height must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.

Motorgiungla

Access limitations: minimum height 105 cm – maximum height 121 cm– for further requirements, consult the specific sign at the entrance to the attraction.

Carousel

Access limitations: minimum age 3 years – children of age less than 10 years must be accompanied – for further requirements, consult the specific sign at the entrance to the attraction.
